LAS TRES ISLAS 2006 – RULES AND REGULATIONS (waiver, release and indemnification form)

1. Organisers

- a) Las Tres Islas 2006 (referred to from here on as "the Event") is being organised by Youths United, S.L. (referred to from here on as "the Organisers" - contact details below), and will take place on Saturday 27th May 2006.

2. Health and fitness, event safety and insurance

- a) I fully absolve any responsibility of the Organisers, and their volunteers of the event, for any physical or material damage that may be caused by me, or occur to me before, during, or after the Event, including training.
- b) I state that I am physically fit, can swim (if partaking in the swim or sail) and cycle (if partaking in the cycle) competently, have trained sufficiently for the event and that a licensed medical doctor has verified my physical condition.
- c) I consent to receive medical treatment by any medically-trained authority, which may be deemed advisable in the event of injury, accident and/or illness during the event
- d) The Organisers will provide a sufficient safety net of first aiders and safety boats for the event, who will be available for the help and assistance of the competitors, but I understand that as a competitor I will be responsible for my own personal insurance and/or the insurance of my personal equipment and possessions.

3. Entrance, fees, and the Event in general

- a) The organisers reserve the right to admit, or not, any given competitor to enter all or any part of the Event.
- b) Volunteers chosen by the Organisers will be assisting the Organisers on the day with the running of the Event. These Volunteers will be taking orders and guidance from the Organisers, but I agree that in extreme circumstances, where they feel the personal safety of the competitors may be at risk, to abide by the decisions of these Volunteers.
- c) I Agree to fully abide by advice given to me, and decisions and rules made by the Organisers regarding the Event. The judges decision is final.
- d) I understand that although the Event is only one day, competing may involve me staying in La Graciosa island for the night before the event, and if I choose, in Fuerteventura on the night of the event. I understand that I am solely responsible for all financial costs relating to personal and equipment transport, accommodation, and other costs not specified as included in the entrance fee.
- e) I understand that the Event, in certain aspects, is weather-dependent and therefore out of the control of the Organisers, and that in the unlikely circumstances of adverse weather conditions the Organisers reserve the right to postpone or cancel all or part of the Event without refund.

4. Personal possessions

- a) I acknowledge that I am solely responsible for all my personal possessions and equipment (including bikes & watercraft), before, during and after the Event.

5. Use of competitor details

- a) I permit the free use of my name and picture in broadcasts, telecasts and the press as they pertain to the Event.
- b) In accordance with the Spanish Constitutional Law 15/1999 of the 13th of December relating to the Protection of Personal Data, you are made aware that by your participation in the event you give your consent to include your details in the existing database automatically generated by the Organisers. The aim of the database is to manage and develop the Event, and other future events by the Organisers.

I REALISE THAT BY SUBMITTING MY ENTRY FORM TO THE EVENT, I AM STATING THAT I HAVE READ, UNDERSTOOD AND AGREE TO ABIDE BY THIS WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT and further agree that no oral representations, statement or inducements apart from the foregoing agreement have been made.
